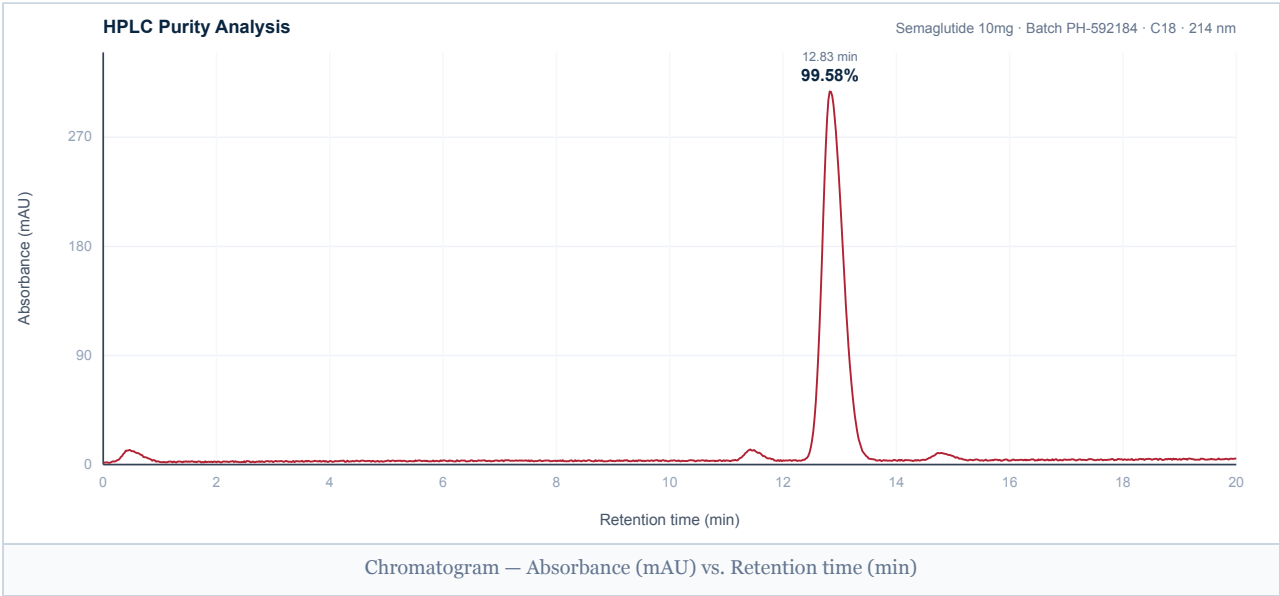

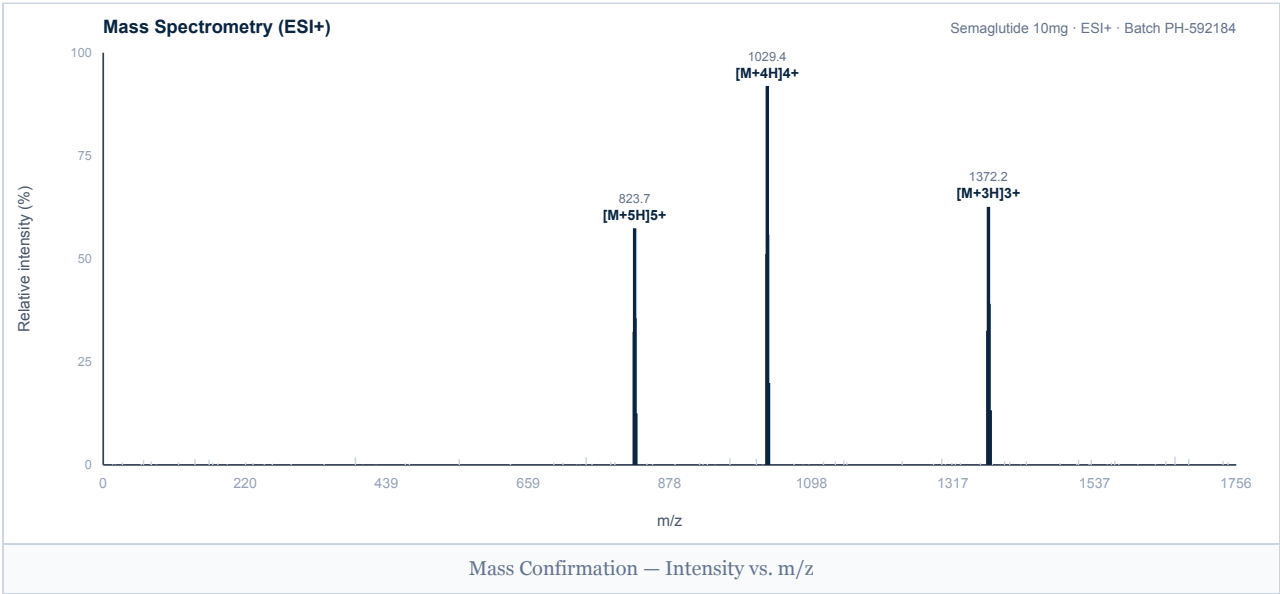

CONCLUSION

Identity of Semaglutide confirmed by LC-MS (deconvoluted mass 4113.59 Da matches the theoretical 4113.58 Da within tolerance). HPLC purity 99.58% (main peak 12.83 min). Measured content 10.14 mg is within $\pm 10\%$ of the 10 mg label claim. Endotoxin, heavy metals and sterility screening within acceptance limits. Sample passes.

GLP-1 receptor agonist. Minor peptide-related impurities (deletion/truncated sequences) detected at trace levels; each individual impurity below the 0.5% identification threshold (Ph. Eur. Substances for Pharmaceutical Use).
